### **Personal Data Protection Policy**

BCI Asia Construction Information Ltd together with its subsidiaries, affiliates, related and associated companies (collectively referred to as "**BCI Asia**") respects and is committed to the protection of your personal data and your privacy. This Personal Data Protection Policy ("**Policy**") explains how BCI Asia collects and handles your personal data in accordance with the Personal Data (Privacy) Ordinance of Hong Kong SAR (Cap. 486) ("Ordinance"). BCI requires that all its officers, management, and members of staff comply with the obligations under the Ordinance.

BCI Asia may amend this Policy at any time without prior notice and will notify you of any such amendments via our website or by such other means of communication as deemed suitable by BCI Asia. The handling of personal data will be governed by the most recent version of the Policy, available at <u>www.bciasia.com</u>.

## (1) Personal Data

## 1.1 Type of personal data

In this Policy, personal data as defined in the Ordinance, includes any information which relates to you or in respect of a third party and which was collected by or provided to BCI Asia for any of the purposes stated in Section 2 below ("**Purposes**").

Your personal data collected for the Purposes may include, but is not limited to, your name, details of your immediate employer, job title, the project you are handling and contact details such as email address, telephone numbers, fax number and business address.

### 1.2 Source of personal data

BCI Asia may collect your personal data from: (i) publicly available sources including your company's website, newspapers, magazines, documents submitted to the regulatory authorities, government publications, online directories, official licensing or registration databases, or (ii) directly from you via telephone calls, email correspondences, or (iii) indirectly through third parties.

### 1.3 Obligatory personal data

BCI Asia will inform you where the personal data is obligatory to be provided by you or if it is strictly on a voluntary basis only. Should you fail to provide the obligatory personal data, we may be unable to process your request and / or provide you with the relevant service and products requested. All personal data provided to researchers in the course of researching and reporting on construction projects is done so voluntarily. There is no obligation to provide project related information.

### (2) Purposes of collecting and further processing (including disclosing) your personal data

Your personal data is collected and further processed by BCI Asia as required or permitted by law and to give effect to the following transactions:

□ to include your personal data into our database of projects and that of their participating consultants, contractors and other related organisations by limited access through subscription;

□ to provide project leads and construction industry intelligence to our clients through their purchase of our products and services;

 $\hfill\square$  to manage and improve the quality of our products and / or services offered;

□ to comply with BCI Asia's legal and regulatory obligations;

□ for internal investigations, compliance, audit or security purposes including without limitation crime detection, prevention and prosecution;

□ to conduct research for internal marketing analysis and analysis of customer patterns and choices;

 $\hfill\square$  to better manage our business and your relationship with BCI Asia;

□ to ensure that the contents on our website are presented in the most effective manner for you and for your computer and / or device;

 $\Box for \mbox{ BCI}$  Asia's internal records management; or

□ for any other purpose that is required by any laws, regulations and guidelines including the requirements of any governmental or regulatory authorities.

## (3) Protection measures

BCI Asia may securely store your personal data in different ways, including in hard copy and electronic form. Generally, personal data is maintained on a secure database located in Singapore.

BCI Asia takes such steps as are reasonable in the circumstances to protect your personal data from risks such as misuse, interference and loss, and from unauthorised or accidental access, modification, disclosure or other use. These steps include:

- training and reminding our staff of their obligations with regard to your personal data;
- using software which encrypts personal data (where a lock symbol appears on the browser window);
- utilising passwords, firewalls and virus scanning tools, and protection in buildings where personal data is stored, to prevent against unauthorised access to our systems; and
- restricting staff and volunteers that have access to the databases that store user personal data and to personal files.

Where we no longer require your personal data, BCI Asia will take reasonable steps to destroy it.

# (4) Accuracy of personal data

BCI Asia take certain measures to ensure that the personal data is reasonably accurate, complete and is relevant to the Purposes. However, BCI Asia also relies on you to promptly inform us in writing of any errors or changes in the personal data.

### (5) Retention of personal data

BCI Asia's policy is to retain personal data for no longer than is necessary for the fulfilment of the Purposes (or any directly related purpose) unless the personal data is also retained to satisfy any applicable statutory or contractual obligations. Different retention periods apply to the various kinds of personal data collected and held by BCI Asia.

## (6) Disclosure or transfer of personal data (within or outside of Hong Kong SAR)

### 6.1 Entities within BCI Asia

Your personal data may be processed by us and / or other entities (within or outside of Hong Kong SAR) within the BCI Asia group of companies (including related companies, subsidiaries, holding companies, associated companies.).

BCI Asia will ensure that:

 access to your personal data is restricted to employees who are reasonably required to process your personal data only in accordance with their assigned duties; and
only necessary information will be released to the relevant employees.

### 6.2 Classes of third parties

Your personal data may be disclosed or transferred to relevant third parties (within or outside of Hong Kong SAR) as required under law, pursuant to relevant contractual relationships (for example, where we appoint a third party service provider) or for the Purposes above.

In the event of a potential, proposed or actual sale/disposal of business or interest, acquisition, merger, re-organisation or funding exercise relating to any member of BCI Asia ("**Transaction**"), your personal data may be required to be disclosed or transferred to a third party as a result of the Transaction. You hereby acknowledge that such disclosure and transfer may occur and permit BCI Asia to release your personal data to such third parties and their advisers/representatives.

Your personal data may be disclosed to the following classes of third parties:

□ to our clients who purchase our products and / or services in order to contact you, on behalf of your company, in relation to its business;

□ law enforcement agencies including courts, tribunals or authorities, whether governmental or quasigovernmental having jurisdictions over BCI Asia;

□ relevant governmental agencies, statutory authorities, industry regulators and local councils; and

□ any persons, authorities or regulators to whom BCI Asia is permitted or required to disclose to under the laws of any country.

## (7) Websites

## 7.1 Links to other sites

Contents of BCI Asia's website may include links to third party websites. BCI Asia is not responsible for the contents on such linked third party websites and users should observe the separate privacy policies applicable to the respective third party websites.

## 7.2 Cookies

BCI Asia may collect unidentifiable information about your visits to BCI Asia's website without your active submission of information

Unidentifiable information may be collected using various technologies, such as cookies and web beacons. Cookies are small text files that are transferred to your computer's hard disk by a website. Web beacons (also referred to as GIF files, pixels or Internet tags) help BCI Asia recognise a unique cookie on your browser. Your internet browser automatically transmits some of this unidentifiable information to BCI Asia such as the URL of the website you have visited and the version of the browser in which your computer is operating.

Passive information collection technologies can make your use of BCI Asia's website easier by allowing BCI Asia to provide better service, customise the BCI Asia's website based on consumer preferences, compile statistics, analyse trends and otherwise administer and improve BCI Asia's websites. Certain features of BCI Asia's website may not work without the usage of the passive information collection technologies. Information collected by these technologies cannot be used to identify you without additional identifiable information and BCI Asia will not collect such additional identifiable information through the usage of such tracking technologies.

### (8) Right to access and correct personal data

You have the right to access and correct your personal data held by us, subject always to certain exemptions. We will make every endeavour to ensure your personal data is accurate and up-to-date and therefore we ask that if there are any changes to your information, you should notify us directly at the contact details set out in Section (9) below.

### (9) Limiting the processing of personal data, further enquiries and complaints
